

MINUTES

Minutes of the meeting of the Choice Based Credit System (CBCS) Oversight Committee, held on 16.02.2016 at 3.00 P.M. in the Committee Room of the Finance Officer, University of Delhi, Delhi-110007.

The Chairman welcomes the members and apprise them about the Agenda after that the Committee considered the Agenda item wise.

(I) The Committee **considered** the letter No. MILLS/2016/1839 dated 5.2.2016 received from the Head, Department of Modern Indian Language and Literary Studies duly forwarded by the Dean, Faculty of Arts regarding Syllabi of Tamil and Telugu for B.Com.(Hons) students under Choice Based Credit System (CBCS).

The Committee deliberated on the structure of B.A./B.Com.(Prog.) and B.A.(Hons) and B.Com(Hons) Programme under CBCS and arrived at a decision that the students admitted under B.Com(Hons)/B.A.(Hons) Programme will be studying MIL for one Semester in first year under Ability Enhancement Communication Courses (AECC). Further the students admitted under B.A./B.Com(Prog.) under CBCS will be studying MIL as part of their Core Language paper and in Ability Enhancement Communication Courses (AECC). The Committee also considered the fact that the Department of MIL & LS has prepared Syllabi (which has been approved by AC & EC) for B.A.(Prog.) under Choice Based Credit System (CBCS) only. The O.S.D.(Exams) informed the Committee that the examination of students who have opted for Tamil and Telugu as part of their Ability Enhancement Communication Courses (AECC), and Core Language was held during the end semester exam of B.A.(Prog.) I Semester under CBCS.

In view of the above and the fact that major part of the II Semester is over, the Committee **resolved** that the students of B.Com (Hons) and B.Com (Prog.) in the II Semester who opt for Tamil and/or Telugu may be taught, the Course approved for B.A.(Prog.). Further the Department of MIL & LS may be advised to get the Syllabi prepared and approved by the Competent Authority for students of B.Com (Hons) and B.Com (Prog.) before the start of the next semester.


(II) The Committee considered the Email dated 28.1.2016 of Sh.Dinesh Kumar, Associate Professor, Dyal Singh College, wherein he has given some suggestions for tutorials.

The Committee **resolved** that the suggestions of Sh. Dinesh Kumar may be discussed and acted upon by the Colleges and decision to that effect may be taken in accordance with the rules of the University.

(III) The O.S.D. (Examination) apprised the Committee about the requests being received in his office from the students for knowing the absolute marks secured by them in a particular paper. The O.S.D. further informed the Committee that as per the provisions of the UGC template for declaration of result under CBCS, Examination Branch is denying the request of the students for absolute marks.

The Committee **resolved** that the decision on the issue may be taken in accordance with the provisions made by the UGC.
